## Woodland students revisit Holocaust

**Kildeer author survived Nazi concentration camp**

GURNEE—The Holocaust and genocide were brought to life for Woodland Middle School eighth-graders Monday. They handled artifacts from a traveling Holocaust exhibit and heard the harrowing account of one survivor.

"This is an important part of history. I didn't want it to go unnoticed," said student Julia Freeman, 14, who was unofficially responsible for the general presentation.

Her principal speaker was Dede Harris, wife of Sam Harris, author of "Sammy: Child Survivor of the Holocaust."

Nazis invaded Sam's village in Poland when he was 4. One of his early memories is seeing his father after soldiers beat him to a bloody pulp.

Rather than stand in line with his parents and neighbors

to board a train to a concentration camp, Sam and two of his sisters hid.

To survive, they later snuck into another concentration camp, where they managed to stay alive until the war ended.

He immigrated to the United States when he was 12 and was adopted by a Northbrook family.

"I don't want anyone to feel sorry for the things I went through," Sam said in a taped interview played at the Woodland assembly.

Sam could not attend, but Dede said she has heard her husband's story so much, it's almost like she lived it.

"I enjoy telling it. I think it's a very important piece of his-

"We try to have Holocaust speakers in every year, but they're hard to arrange," said Freeman's teacher, Adrienne Barkhurst.

Her students have spent three weeks on a genocide and Holocaust unit. She said the goal of Monday's event was to provide a "more personal view on the Holocaust and genocide."

Freeman said she liked the exhibit and loved how much she was learning. "It really hits home because I'm Jewish, too," Freeman said.
